A true copy of the title and text of any Amendments or Referendums to be voted upon will be published by the Secretary of State once each week for three consecutive weeks preceding the election.

If the names of candidates filed for nomination at the primary election for directors of natural resources districts, members of the board of school districts which nominate candidates at the primary election and officers of the cities, do not exceed two candidates for each position to be filled, such candidates shall be declared nominated and their names shall not appear on the primary election ballot.

Therefore the following sub-divisions will not appear on the primary election ballot (Nebr. Statute Section 32-811) but will appear on the general election ballot.


